PERATURAN BERKENAAN AKTIVITI
PERKHIDMATAN BOT PENUMPANG DI
DALAM HAD PELABUHAN KEMAMAN

RULES PERTAINING SERVICES BY
PASSENGER BOAT ACTIVITY IN KEMAMAN
PORT LIMIT

Sebarang aktiviti perkhidmatan bot penumpang di dalam Had Pelabuhan Kemaman hendaklah mematuhi peraturan seperti berikut:

Any service by passenger boat activity conducted within Kemaman Port Limit shall comply to following rules:

- 1) Hanya bot penumpang yang dilesenkan oleh Jabatan Laut Malaysia dibenarkan beroperasi untuk aktiviti pemindahan penumpang dari / ke kapal.
- 2) Nakhoda kapal hendaklah melaksanakan Declaration of Security (DoS) seperti dikehendaki kod International Ship and Port Facility Security (ISPS) setiap kali aktiviti pemindahan penumpang dari / ke kapal dijalankan.
- 3) Nakhoda bot penumpang hendaklah melengkapkan Buku Log Sekuriti seperti dilampirkan dalam pekeliling ini setiap kali aktiviti pemindahan penumpang dari / ke kapal dijalankan. Buku log ini perlulah disimpan di atas bot pada setiap masa bagi tujuan pemantauan oleh agensi penguatkuasaan dan pihak pelabuhan.

- 1) Only passenger boats licensed by Marine Department of Malaysia are permitted to operate passenger transfer activity from / to any vessel.
- 2) Master of vessel shall exercise Declaration of Security (DoS) as per required by the International Ship and Port Facility Security (ISPS) Code every time passenger transfer activity from / to any vessel is conducted.
- 3) Master of passenger boat shall complete the Security Log Book as attached in this circular every time passenger transfer activity from / to any vessel is conducted. The Log Book shall be readily available at all time onboard for inspection by the authority and the port.

Ketidakpatuhan terhadap peraturan ini adalah satu kesalahan dan tertakluk kepada perundangan oleh Jabatan Laut Malaysia.

Noncompliance to these rules is considered an offense and subject to legal action by Marine Department of Malaysia.
